## From Larry Voris, our President and Director-at-Large

Our second summer has arrived. The first was in February and March when we had some 70 & 80 degree weather. I got my winter project completed a few weeks ago, and it is ready for the National show to be held in Billings, MT in mid-August. I'm still kicking the "paint" thing around. If I paint it, then I'll have to be more careful on how I use it. Now, I can load it on the trailer, throw a strap over it and we're ready to go.

We need to discuss the benefit package that EDGETA furnishes its members. As I have related in the past, EDGETA is not Insurance Company. We purchase a policy that covers our members. I will tell you all again how this works. I have clubs call and want to buy insurance to cover their activities. We do not have a license to sell insurance, and I wish you all would wipe this out of your vocabulary. By being a member of EDGETA, you receive the benefit package. When your club joins EDGETA, you are now known as Branch 302 or the next number in line. We don't know anything about "The Hoot's Holler Tractor & Engine Club." When you write and ask if this club has benefits, you will probably get a "No" answer. If you write and ask about Branch 302, then you will get a "Yes" answer. On your letterhead and your web sites, I want to see the EDGETA Logo, and Hoot'n Holler Tractor & Engine Club, Branch 302 of the Early Day Gas Engine & Tractor Assn. If we are going to furnish you benefits, then EDGETA should be recognized, too.

It seems that when we get a new branch, they agree to all of our guidelines for tractor pulls. This means 3.5 mph--NOT 4.0, 6.0 or 10.0 mph. If you need to run these higher speeds, then you are in the wrong place. You can't have an EDGETA pull and then announce that the next 4 classes will be covered by "xyz insurance company." If you have the performance pulls, they need to be on a different time and day and under a different name; then their insurance covers the whole thing.

Next, if we have needs to lease fair grounds, museum grounds or a public place, be very careful on what you sign.

We want to cover only the area that we are responsible for. We must mark the area that we are going to use, and the rest belongs to someone else. We are not going to use our benefit program to cover something that we are not using nor have access to.

If anyone uses volunteers or helpers at an EDGETA sponsored show, the volunteers and helpers must be members. We had our Insurance cancelled this year when a branch used a volunteer and that person was injured. This was an expensive lesson for EDGETA. We have to think before we let someone help us. Ask them if they are an EDGETA member before letting them help. If they aren't a member, just say sorry you have to be a member before you can help us.

This is another subject that we need to address. If one of our members is injured, how many of our members have hospital insurance to cover an incident that might happen?

You all can go on line at [www.edgeta.com](http://www.edgeta.com) and read the safety guidelines. It will help you and everyone in the organization if we follow the guidelines that the Board of Directors has set forth. These safety guidelines are what help us purchase the benefit package at a very reasonable price.

Hope to see you all down the road at a show somewhere.

## Insurance Update July 2012 by Johnny Burger SC Director

The stated purpose of EDGETA is **"To promote collection, restoration, preservation and exhibition of gasoline and oil engines, gas and steam tractors, power driven machinery and other equipment of historical value and, further, to promote the fellowship of those with common interests."**

On the 15th of April, 2012, we lost our insurance because of excessive claims from last year. We had a new insurance carrier on April 16, and the cost went up. Around the 1st of April, I was made chairperson of the insurance committee. On April 16, you

should have been in my shoes. Our insurance agent sent out over twenty-one proof of insurance certificates. Some clubs were in a panic to get the certificate. I would like to see the same effort in following our safety rules or participating in EDGETA the way it was intended to be.

Have you checked out what it would cost for non-EDGETA insurance for just one show? Tractor pull insurance from an outside agency for one show runs about \$2500.00 per event. Some clubs have a tractor pull as often as three weeks in a row. It is obvious that these clubs do not exist for the purposes for which EDGETA exists. Many of these clubs don't want an EDGETA officer at their show because they knowingly break our rules, but they get the cheaper insurance from EDGETA at the expense of the rest of us who follow the rules. One branch attempted to provide EDGETA insurance to non-members for an individual event. They stated they did not want these pullers to be full members of their club. This should not be allowed.

I have even had a request for insurance coverage from an individual who owned several tractors. He was mostly interested in receiving the insurance advantage. An individual cannot receive EDGETA benefits without being a member of a sanctioned branch.

The application to join EDGETA that each branch filled out required that you understand and agree with our safety rules. All clubs that joined EDGETA put "Yes" on this question.

EDGETA officers put together safety rules in hopes of keeping down accidents and to get cheaper insurance for all of us. In our branches, we have people who have worked in almost all skills including insurance. I get calls from representatives of a pulling club who want to see the insurance policy. They could care less about our rules. They want to know if the club is covered, even if basic rules are being consistently broken.

Last year we had so many accidents, the insurance dropped us. Some of these accidents could have been prevented by following our safety rules. Most importantly, all branches should be required to allow only stock, antique tractors to pull. Pulling clubs which do not follow the stated purposes of EDGETA, as stated in the first paragraph, would have no interest in or reason to join EDGETA if insurance were not available. I see nothing wrong with hooking an old tractor to a sled to see what it can do, but when you rebuild the tractor for power just to win a trophy or money, you no longer serve our purpose. Most pulling clubs want to change our rules to allow them to run faster, have more weight, etc. They join EDGETA only for the insurance

and, therefore, threaten our financial security.

At the national meeting in Billings, Montana, this year, I would like for all officers to review our rules concerning membership requirements to see if certain areas could be improved. I think it is vital to the existence of our great national organization that we strengthen our rules to protect EDGETA from those who consistently, and on purpose, seem to violate the mission of our organization. By breaking rules through their practices in conducting only pulling events and breaking rules likewise in regular club activities, they jeopardize the rights of all members. Branches consistently and purposely breaking our rules should result in being removed from our roster

**SAFETY HELPS US ALL**

Last year we lost our insurance and had to get another company to cover us. The cause was too many claims that were costly. Because of this, our insurance premium will go up and so will the cost to you. This member year you pay \$4 for dues and \$4 for insurance. We, at National, will absorb the increase for insurance for this year, but next year the insurance cost could double or triple to you.

It is very important for you to read our safety requirements and follow them. We need to have years with no claims, and we can only accomplish this with all of you following the safety requirements.

One of the biggest claims was when a branch let a non-member (spectator) volunteer at a pull on the pulling sled. The non-member got hurt when the weight came back on him.

Remember, if you do not follow our safety requirements or enjoy this hobby in a safe manner, it reflects on and hurts every member of this association. If one member makes a mistake or acts foolishly it costs us all.

A helpful suggestion would be to have your safety officer download the safety requirements and go over them at your meetings and/or your shows. If you don't understand something, we all would be glad to help or discuss it with you.

I handled this aspect of the EDGETA organization for about 10 years and decided it was time to turn it over to another director. I am sure Johnny will do a good job in answering your questions. I have enjoyed talking to members of the branches and helping you with your questions. If you have a question that you think I can help you with, please feel free to call or email me.

As we get into the show season, remember to keep thinking about safety. In the last couple of years, we have had several big claims that could have been avoided. As a result, our EDGETA insurance premiums will go up for next year. We all need to work together to reverse this trend and prevent accidents from happening. It will require each of us to keep safety on the top of our list every day. As I think I have told you before, we had a saying where I worked before I retired to "Take 2" before you acted. Take 2 seconds, 2 minutes, or whatever it takes to think through what you are about to do to be sure it is a safe act.

We are at a busy time of the year for our branch. As you know my Branch 29 will host the National EDGETA show and meeting this year in conjunction with our Huntley Project Threshing Bee, just east of Billings Montana. It will be held on August 18-19. We have been working diligently to make sure we will

provide a show that you will remember and enjoy. We will feature IHC equipment in conjunction with the new Chapter 40 of the International Harvesters Collectors Club, which has just been formed in Montana. Yes, all their members that exhibit any equipment are EDGETA members. Our show is more active than most shows; we encourage exhibitors to show how their equipment was used in the past. We encourage members to demonstrate their equipment and participate in tractor games and the tractor pull. Our tractor pull is more for fun; we do not have classes, but each tractor hooks on to see how far they can go. We bind grain on site and thresh with steam and gas tractors. After it is cleaned, it is ground into flour and baked into bread with Dutch ovens. We have a blacksmith shop complete with a line shaft. We have a sawmill with a planer, edger, buzz saw, and a shingle mill. We exhibit plowing with gas tractors and steam engines. A members' breakfast is served each day starting at 7 am. Our show starts at 10 am and wraps up about 4 pm. On Saturday, we will have the EDGETA National Meeting at 5:30 pm followed by dinner about 6:00 pm. We have a local poet that will entertain us with stories of farming and ranching in the old days. We request that you pass this information on to your members and encourage them to come to the Big Sky Country. Montana is a great place to vacation. If you can join us, and we hope you can, there is an RSVP form on our website that we request you fill out and return to us so that we can reserve space for your exhibit, RV or for the Saturday evening meal. It will help us do our best to accommodate your time with us. RV parking is available at the show grounds, but there is a busy, noisy train track nearby. We are arranging for parking spots away from the busy track that are quieter, but we need to know if you need a RV spot so we can plan for it and accommodate you. All spots are dry camping. If you have any questions regarding the National Show that I can help you with, please contact me.

Another practice that some members do is use only two ramps when loading narrow front end tractors. Be aware of your local laws in securing your equipment to your trailer. If you will be passing thru other States, check their laws as well.

There is a local branch that refuses to mail the year stickers to members that have paid by mail. Also, our membership year is from April 15th til April 15th and you must not remove the sticker that is on your yellow card until April 15th. It is an unnecessary burden on our very busy secretary to need to contact her to find out if and when a member is current. For the new members that join, a copy of the safety rules that may pertain to them and a copy of the bylaws would be helpful to them. Many times I have seen new members do something that is unsafe or against the rules because they don't know.

I appreciate all the calls and emails that I receive concerning safety and youth driver questions. So far this year I have issued over two dozen youth driver cards, which is a great indication that we have young people that are interested in our hobby.

Just like the first folks to play baseball or put on that farm equipment show, someone has to say that it is a great idea. I would like to do that. It is very important that everyone, not just a couple of people, but everyone of our exhibitors observe the guidelines for safe practice while putting on a show. Without everyone working together as a team, no one is protected. You cannot look over the actions of some just because of who they are or something like that. The guidelines are there for two

reasons: (1) to protect the public from harmful old equipment made before all the safety features and (2) to protect the exhibitors from the public. I have said it before. It takes everyone working together to make the show experience a safe one.

Just as a side note. Thirty-five years ago, I lost my big toe and second toe on my right foot under a riding mower. If the safety features that are on new mowers today were on that mower then, I would still have all of my toes. You see, I was doing something very unsafe. I did not think it was at the time, but now that it is all over, I know it was not good to stand behind a riding mower while someone is operating it in a live grass-cutting mode. It only takes a second for something to go wrong.

That is all it takes, a second! Please take the time to learn these guidelines and practice them. Make sure your neighbor knows and practices them as well. Safety is all of our jobs! Have a safe show season, and I hope to see ya'll out there.

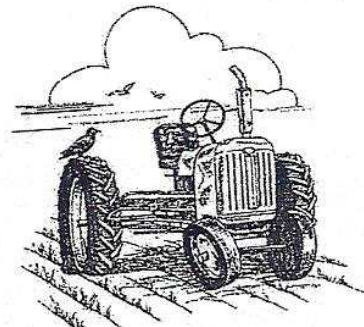
