Many of you know the new Director-at-Large, Buster Brown. Buster was voted in at the National Annual Meeting. Buster has been very involved in the preservation of antique farm equipment for many years. He is a President of Branch 206. Please welcome Buster as the new Director-at-Large.

Everyone should have their memberships and dues paid by now. It is very important when you report your members that you include their name,

address and phone number. These are important pieces of information. Please note the information needed on the **BRANCH MEMBERS FORM**. It is required for the insurance coverage to be in effect for each member. You must report new members within 30 days. It is also required that each branch complete both the **BRANCH OFFICERS and also DIRECTORS UPDATE FORM**. These forms serve to help us identify who can be contacted at the branch. It verifies the officers for the D & O insurance. The form is set currently so that if there is not a change for a specific position, you can fill it in with the word “same,” submit it and the form will let the secretary know the correct contacts for your branch.

Unfortunately, we have had a noticed decrease in the membership from last year. We have had some branches drop their membership. This was discussed at length during the board meeting this year as to what could be done to retain current members, but also attract new members. As with any organization, the life blood is consistent and increased membership. The only way to keep our hobby alive and going is by passing it to the younger generations. There are so many things out there for folks to do and let’s face it, agriculture no longer has the attention of the masses any longer. We do have something that can appeal to everyone and that is a rich history of how things were done and the marvelous machines created to help accomplish those task. Static displays are nice but the generation coming along want to see things work and get involved with it. We also discussed the minimum number of members needed to form a branch and also renew as a branch. We felt this may be an issue for some of our branches. We will be discussing this and bringing it to the membership in the future for vote.

Please review the safety section with your branches. The safety requirements are not optional. You can’t use the ones you like or agree with and ignore the rest. The safety requirements were put

together by members of the organization with experience in operating tractors, engines and the other equipment. These requirements are not difficult to follow. These were put into place to protect the membership. If you are not following them, you could be putting the other members of the organization at risk. A club or organization is a group of people with the same goal or vision. They look out for each other. Please keep that in mind as you are showing off your antique farm machinery.

Please remember any correspondence with the National must include your branch number. When your club applied for membership, your club agreed that it would be known as a Branch of EDGE&TA. That number should be on any documents you send to the national secretary. Your club is Branch #\_\_ of Early Days Gas Engine and Tractor Association. Please make sure you are making your club known as such.

I hope everyone has a safe summer. I look forward to seeing some of you at the shows. Please practice safety to protect spectators but also to protect ourselves.

**Insurance Update, March 2015, By Dick Tombrink, NW Regional Director**

We just had the EDGETA National Meeting for this year in April in Henderson, Texas. This branch is primarily a tractor pulling branch. In addition to the pulling tractors, there were some interesting other exhibits of tractors and stationary engines. It is

always interesting to see what other branches are doing and what other members are restoring.

I also attended the NW Regional Show and meeting at Shoshoni, WY on June 13-14, hosted by Branch 72. They have their show in a park area in Shoshoni. They have a tractor pull for the fun of it, no prizes, just bragging rights they said. In addition, there were stationary engine displays, arts and crafts vendors, three steam engines, and very hospitable people. Unfortunately, our other EDGETA branches did not support them very well. There were only 3 of us from Branch 29, no other branches were represented.

A couple of things came up at the EDGETA National Meeting in Henderson that I want to remind you of. When you sign up a new member, you must issue that person a yellow EDGETA Membership Card immediately with the current sticker on it, and you must send to Carrie Jo that person's name and contact information within 30 days of that date. If you don't, that member does not have insurance.

Also regarding people movers, barrel trains and sleds, if you take your sled to another non EDGETA event, you are not covered by EDGETA insurance. Our insurance does not extend to those situations. If you take it to another place, non EDGETA event, you need to require that entity to provide a Certificate of Insurance naming your branch as additional insured.

After the EDGETA National Meeting, I was discussing swap meets with our insurance agent. In the past when a member was selling parts at his exhibit, they were not covered for that situation. As we talked, our insurance agent said that we do have premise liability insurance. As a result, we have made a change on our EDGETA webpage under insurance, as follows, (the changes shown in italics):

### **"EDGE&TA Branch Swap Meets**

Swap meets are something that must exist in order to continue the search for historical equipment to restore as well as for parts for the equipment that cannot be purchased in the open market.

*Branches who have swap meets, and EDGETA members buying or selling at an EDGETA swap meet or an EDGETA event, are covered by our liability policy for premise liability only. Individual EDGETA members selling their parts/equipment at an EDGETA swap meet or at an EDGETA event have no product liability coverage. (Note that the member is not operating a business as stated below).*

**The EDGE&TA insurance policy does not provide general liability coverage for the products sold/traded.**

EDGE&TA swap meet vendors are not covered by our EDGE&TA insurance policy. Under the present policy conditions, a commercial vendor (truck/trailer load) member or non-member of EDGE&TA is not insured under the EDGE&TA Insurance policy. The EDGE&TA insurance coverage for an EDGE&TA member will not extend to his/her business; we suggest they purchase a commercial liability insurance policy to protect them and EDGE&TA for the products they are selling."

For more information on what premise liability covers, Google it on the internet.

**From Don Young—Vice President and SW Regional Director, Safety Chair, Youth Driver Cert.**

In the past few years, there have been accidents involving loading and unloading tractors. Several years ago, a person was attempting to load his tractor and the engine was not running well. Part way up the ramps, the engine began to run properly and the tractor flipped over backwards, fatally injuring the operator.

There have been at least three more such incidents that I have been aware of, most recently three weeks ago. The same situation--the engine not running well, then corrected itself, and the tractor went over backwards.

Personally, I always back my tractor on a trailer, but that is not for everyone. Possibly a safer way would be to winch it on. It is up to the individual to do whatever they feel is safe.

When I am winching a tractor or engine on the trailer, I attach a chain to the trailer and to the equipment to prevent them from rolling away in case of a winch failure.

We all hope the rest of the show season is safe for everyone.

We went into the emergency room a number of years back with all four of our children in tow. One was already on crutches with a broken ankle and our oldest son was limping. He had scooted his bare foot on the carpet and embedded a sewing needle in his foot.

The nurse looked at my wife and said, "You are

going to have to start paying the preacher more.” After a brief hesitation, my wife pointed to me and said, “He is the preacher.” "Mmmm." We had just moved into town to accept a new pastorate. Moral of this story, be extra careful when charting new territory. No one would have guessed there was a needle in the carpet.

Having spent several years in the commercial brush hogging business, I have learned to expect the unexpected. Be extra careful when operating tractors on hillsides, even if they aren't very steep. A hidden stump on the uphill side or a stump hole on the downhill side can easily flip the tractor.

Every member owes him a “Very Big Thanks” for taking care of that. This may have kept many branches from leaving the EDGETA organization. It would be nice to know why we lost 17 branches last year. I am sure it is not totally old people dropping out.

This bothers me. There is a big difference between making them stay with EDGETA and making them want to stay with the EDGETA organization. This is where our job as managers starts.

I want to thank everyone that voted for me for Director-at-Large. I will do my best to make things better with members in mind. Thanks again.
