Many of you know Jeff Fenske. Jeff is taking over as Director-at-Large. Jeff has been very involved in the preservation of antique farm equipment for many years. He is a President of Branch 8. Please welcome Jeff as the new director-at-large. I look forward to working with Jeff. I know he will be an asset to the board of directors.

Please share this information with all members. The board of directors are members of the association. We are elected by a vote of the membership. Each director serves a term of 3 years. The directors come from the region they live in with the exception of the director-at-large who may live in any of the regions. This is a membership run association. Please look for the information in the newsletters to see when the director position in your respective regions will be up for re-election. Each Director's term is posted with the information for that Director on the administration page of the website. I

encourage all those interested to get involved. It takes all of us to keep our association strong. If you are interested in possibly serving as a director, please contact your regional director or any director and talk to them about serving. There are a lot of good ideas out there, and we would like to hear them.

Please make sure you are updating your officers' information form on the website. It is important for the directors to have up-to-date contact information for each branch. It is also important from an insurance stand point. If the officer's information is not up to date, the officers are not covered by the D&O insurance provided to the officers for each branch. We appreciate the feedback we receive from the members concerning the website. This is how we make improvements. We know everything isn't perfect, and it doesn't always run like a well-oiled machine, but we are working each day to improve it. Please help us make things better for everyone; if you have suggestions on improvements, let us know. Please be patient as we work to make the improvements.

Please remember to include your branch number when corresponding to the national secretary or any of the directors. If you are completing any forms for EDGE&TA you must include your branch number on those as well. The branch number issued when your club joined EDGE&TA is how your branch agreed to be identified during the application process. This speeds up any process concerning your branch.

This section is very important. It needs to be very clear. Each branch is responsible for keeping copies of all membership lists sent to the national secretary. When the branch sends in a membership list, there are several things that need to happen. First, the member list must be complete with member's name, address and phone number. The list will not be accepted if they are not complete. There should also be a check with the correct amount of dues to coincide with the number of members on the list. An example is if you send a list of 25 members along with that completed list, there is to be a check for \$300. That is \$12 per member. The secretary will not accept lists without

complete information or checks without a list of members. If any of the information is incorrect, it will be returned to the branch to be corrected. This may interfere with insurance coverage so make sure you have everything correct before you send it. Remember, if we don't have a name, complete address and correct amount of dues, the individual is not covered. Also, member lists and dues for the year are to be received by the secretary/treasurer on or before March 15. This gives time to record and process everything by the start of the fiscal year. Please contact any of the directors if you have questions.

Currently, the board is looking at different insurance options. We on the board will be discussing the plans and cost. We will then provide that information to the membership. Please keep watching the newsletters and also any correspondence from the national secretary that will have this important information for all of our members.

I hope everyone is having a safe and enjoyable summer. There are lots of shows going on with more on the way. Please take extra time to keep yourself and others safe. If you have any questions or suggestions, please let us know. We look forward to hearing from you and seeing you at the shows.

Insurance Update, July 2018, By Dick Tombrink, NW Regional Director

At this time, I am sure you are aware of the incident that happened in California last September. One of our branch members was participating in a local parade, and accidently ran into the back of a Bentley car ahead of them in the parade. Since our insurance does not have participant liability, the claim

was denied by our insurance carrier. We do not have coverage for an accident involving another participant in a community parade whether they are an EDGETA member or not. As you know, we also do not have coverage for an incident involving another EDGETA member at an EDGETA show.

I have been talking to our insurance agent about the California incident. He has been searching for participant liability coverage for us. He had numerous rejections, but finally he found an Insurance carrier that will provide participant liability coverage for us, both for the case of one of our members participating in a community parade and also for an incident involving another EDGETA member at our shows. This is really good news for us; it fills a gap that we have not been able to cover before. However, it does come with an increase in cost. Presently we are paying \$8 per member per year for insurance in addition to the \$4 for the EDGETA national dues, for a total of \$12. This coverage will cost an additional \$5 per member per year, for a total of \$17. To me, this is a small price to pay for the additional coverage we will be getting.

However, the deductible will increase from the present \$1000 per occurrence to \$2500 per occurrence. This applies both for bodily injury and property damage. At a recent EDGETA Board of Directors meeting we discussed the deductible and decided that EDGETA would pay \$1500 of the deductible. Therefore, the present deductible amount of \$1000 amount will continue be the responsibility of the branch or EDGETA member responsible for the claim.

There is a problem adopting this policy at this time. It will require those members who have paid their dues this year to pay an additional \$5. This can get complicated for the membership chairman to collect the additional \$5 from those individuals. As those collecting membership dues know it is hard to get some members to pay their dues. The EDGETA BOD felt it would be better to wait until next year to adopt this policy. Then the dues to EDGETA would be \$4 for the National Dues and \$13 for the insurance, for a total of \$17.

Adoption of this new insurance policy will provide us with the coverage we do not have now. That is coverage for an incident involving another participant of a community parade and of a member to member incident. This fills a "doughnut hole" that we now have.

Since we have some time before this policy would be adopted next April, we would like for EDGETA

members to contact their directors or contact me at 406-967-6687 with any comments or questions you have regarding this new proposed policy. We would like to have your feedback.

This year, the NW Regional will be held at Tillamook, Oregon, on August 17-19, hosted by branch 159, NW Old Iron Club. Regrettably, I won't be able to attend, as that is the same weekend we have our branch show and Threshing Bee. Morrie Robinson will be filling in for me, I know he will do a good job.

Stay safe and have a good show season this summer.

I realize I have neglected my duties as EDGETA South Central Director, and for that I am sorry. But if the same set of circumstances happened again, I would have to do the same thing again.

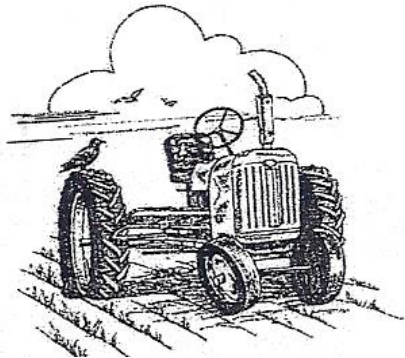
